

Jail Data Updated May 2, 2005

On April 8, 2005 I conducted a new extraction of records from the Jail's database and used the newer version for the following data report. Captain Formolo showed me that I was using the warrants tables for my previous report and that I should be using the warrants activity table instead. I also obtained a new (for me) table called persons that only slightly changed previous information.

In the previous report, I used several different pieces of the database that I see now tends to confuse and distort information. For some of the number of day's data, I used those persons, who were in jail on the 1<sup>st</sup> of January, 2004. These persons were already in jail and consumed many days in the year 2004. I believed since many of these had been in jail for a very long time, that it was important to include their days in custody. In other data relating to other than time in jail, I did not use their data. I should have included their days in jail as a separate piece of the data and not caused confusion.

In the previous reports, I also eliminated those that were shown as booked at other than the RCJC and only included those that had charges showing for them. Those held on detainers or holds for other jurisdiction are not included to help "clean" the data, in my attempt to simplify the information. This missing data may have caused some confusion. For the new data, I have not eliminated groups of data, except where noted.

A major issue that needs to be clearly understood and remembered is the fact that each inmate could and often does confront more than one charge. For that person in jail on multiple charges or holds, there is not way to distinguish for each of those person and each of the charges what there length of stay is for the report when looking at such large numbers of records. For a particular charge, we can "drill down" and see the people that contribute to the reported length of stay. Each of the length of stays reported here amount to the total days in jail for the persons not the charge. The reported length of stay provides direction to look at not hard specific data. The drill down is required to get more accurate information unless we eliminate all who have multiple charges, only then could we have accurate length of stay for charges. Even when doing the drill down to see who makes up the suspect length of stays, one can not attribute the number of days to a charge because it is difficult to attribute days unless they are sentenced days.

For this report, I used only those booking numbers of 2004. I am not using persons who were booked in 2003 or earlier. I have used the number of days in custody for those that were booked or admitted to the jail but remain in custody on the date of extraction during my site visit on April 8, 2005. I used that date as the release date to get the number of days in custody for those that were booked in 2004. Obviously, that group will have more days in custody than shown in this summary. This is necessary to give a number of days for length of stay. I prefer to consider their stay than to eliminate them

from the database because we didn't have a release date. From the database I found the following information:

- There are 13,472 booking numbers,
- There are 12,809 actual records in the inmate table, indicating that 663 numbers were issued or used but the records are not in the inmates table,
- There are 8,972 unique SPN's or person identification numbers, meaning that of the 12,809 bookings 3,833 records are attributed to persons who came to the jail multiple times,
- There are 48 dummy records in the database that are apparently used (I assume) for training purposes,
- Of the 12,809 records, they are distributed by booking facility
  - RACJ            10,861
  - BUPD            329
  - Records        1,649

Captain Formolo indicated that we should eliminate the BUPD and the Records Bureau admissions. Is this accurate? That would put us only 181 different in your number of admissions at 10,679. 12,809 records minus the 1,649 Records Bureau entry leaves 11,160 from which we would deduct 48 "dummy records"<sup>1</sup> to leave 11,112 records.
